1. 37th LAWASIA CONFERENCE

- 4. Travelling, food and accommodation will not be provided and is to be self-financed; and**
- 5. Each sponsored member for the conference needs to submit a short written summary of the entire three-days programme.**
- 6. Members must submit an application for sponsorship stating reasons why the NS Bar Committee should sponsor the candidate.**

Applications for sponsorship need to be submitted to the NS Bar Secretariat **before 2 pm on 26 August 2024**. The decision made by the Committee shall be final.
