COMPUTER GENERATED CIRCULAR NO. 14 OF 2024

To all Members and Pupils of the Negeri Sembilan Bar,

1. COURTESY CALL / MEETING WITH PENGARAH MAHKAMAH SEREMBAN HELD ON 20/03/2024

Further to our Circular No. 9 of 2024, kindly be informed that the Courtesy Call / Meeting with the Pengarah Mahkamah Negeri Sembilan on 20/3/2024 was attended by:

Pengarah Mahkamah Seremban, Tuan Meor Sulaiman bin Ahmad Tarmizi, Datin Surita Binti Budin (Hakim Penyelia Sivil), Tuan Mohamad Kamil Bin Nizam (Hakim Penyelia Jenayah), Puan Naziah Binti Alias (Timbalan Pendaftar Mahkamah Tinggi), Puan Yusna Khadijah Binti Md Yusop (Penolong Kanan Pendaftar Mahkamah Rendah), Puan Loh (Penolong Kanan Pendafter) as well as other Court Registrars and Officers and the following were brought up and discussed :

1.1 PROBLEMS RELATED TO THE EXECUTION OF WARRANT OF ARREST

The court is unable to provide more than one bailiff in an execution there are too many execution proceedings. Where necessary, members may make a formal application to the Court to seek assistance of a police officer following two failed attempts to execute the Warrant of Arrest and such application will be decided based on the discretion of the Court.

1.2 HEARING DATES FOR ACCIDENT MATTERS IN PUAN MAZNI'S COURT

The issue of hearing dates being fixed in 2025 and 2026 in Puan Mazni's court is due to the very high numbers of new as well as pending accident cases in her Court. Also, Puan Mazni is scheduled to retire next year. For members having accident matters in Puan Mazni's Court, it is suggested that members request to fix such matters for Mediation at the Mediation Court first to try and resolve these matters earlier.

1.3 PARKING

The Court has reiterated that all the parking lots in the Seremban Court Complex have already been allocated either to Court staff, DPPs and 5 for lawyers and there are no empty parking lots. We requested for lawyers to be allowed to park in the empty parking lots designated for court staff after a certain cut off time eg. 9.30 am in the morning and 2.30 pm in the afternoon. The Court said the security is not able to monitor this as there is no man power to supervise. However, the NS Bar Committee can write in to the Court with suggestions on ways to use designated parking lots which are unutilised for the day by the Court staff for their consideration. Members are requested to email to the Committee your suggestions to resolve the parking issues.



1.4 NATIONAL LEGAL AID BOOTH/HARI BANTUAN GUAMAN IN COURT EVERY 1ST WEDNESDAY OF THE MONTH

We requested for permission to open a NS Legal Aid Booth in the Court premises every first Wednesday of the month to provide to the public access to free legal advice. The Court has agreed to allow us to use the Court Complex lobby area for Hari Bantuan Guaman which will be held every first Wednesday of each month. Volunteers will be required. Kindly contact Puan Ardelliza Izmaryanti, the Negeri Sembilan Legal Aid Centre Chairperson or the Negeri Sembilan Legal Aid Centre.

1.5 BAR & BENCH GAMES

Persuant to the successful Bar & Bench Games last term, the Court would like to continue with the Bar & Bench Games tradition. It was agreed that the Bar & Bench games will be held later this year with proposed additional indoor games such as carrom and darts.

1.6 E-REVIEW AND TRIALS DATE

We reminded the court of to Arahan Amalan Hakim Besar Malaya Bil. 1 Tahun 2020, Pengarah Mahkamah Seremban has agreed and reminded all his officers that all e-reviews should end at 3.00 pm on the Case Management date. Trial dates will be fixed considering counsel's free dates.

1.7 JOINT WORKING COMMITTEE (JWC)

The Committee requested for a full Joint Working Committee Meeting (JWC) with the High Court Judges to be fixed. The Court informed us that they will fix a date for a full JWC meeting with the High Court Judges as soon as possible.

1.8 UPDATE ON THE MEMBERS' DETAILS IN THE MALAYSIAN BAR WEBSITE
